Call to Order of the September 11, 2007, Meeting

Approval of Minutes

On a motion by Vince Nedimyer and Charles Glasser, the minutes of the August 7, 2007 meeting were approved with the correction that Kathy Getz was elected to serve as the Female Representative on the PIAA State Board of Directors for one year.

Eligibility Hearings

On a motion by David Crumrine and Kathy Getz, eligibility was granted to Denis Zukic, transferring from HS of Economics, Bosnia to Westmont. Denis is eligible to participate in basketball at Westmont based on Article VI, Transfer and Residence. The vote was 14-0.

On a motion by James Price and Thomas Kakabar, eligibility was granted to Brian Sweeney, transferring from Hollidaysburg to Bishop Guilfoyle. Brian is eligible to participate in football at Bishop Guilfoyle based on Article VI, Transfer and Residence, Section 21. The vote was 12-0-2; Dean Rossi and Kenneth Salem abstained from voting.

On a motion by Alberta Ake and Donald Hosterman, eligibility was granted to Blake Morder, transferring from Mount Union to Southern Huntingdon. Blake is eligible to participate in wrestling at Southern Huntingdon based on Article VI, Transfer and Residence, Section 21. The vote was 14-0.

On a motion by Vince Nedimyer and Kathy Getz, eligibility was granted to Adam Laughard, transferring from Blacklick Valley to Bishop Carroll. Adam is eligible to participate in football at Bishop Carroll based on Article VI, Transfer and Residence, Section 21. The vote was 13-0-1; Kenneth Salem abstained from voting.
