The Committee discussed a donation in lieu of flowers to be submitted to the Summerhill Township Volunteer Fire Company.

Curtis Whitesel updated the Committee on AAA golf that will be held at Sinking Valley Country Club on the 21<sup>st</sup> and the need of monitors and coaches to assist at the tournament.
