**Regular Meeting of PIAA District VI – March 13, 2024**

**Call to Order** of the March 13, 2024 meeting, Chairman Marshall called the meeting of the District VI Committee to order at 3:30 p.m. at Penn Cambria High School.

**Approval of Minutes**

On a motion by Dane Harrold and Tish Maclay, the minutes from the February 5, 2024 meeting were unanimously approved.

**Financial Reports**

On a motion by Curtis Whitesel and Timothy Regan, the Committee unanimously approved the District VI monthly financial report for January.

**Old Business**

Phil Riccio updated the Committee on the state wrestling meeting scheduled on the 27<sup>th</sup> and the increasing numbers for girls wrestling and championships.

William Marshall informed the Committee on the outstanding crowds and fans at the District VI Basketball Championships, live streaming effects on ticket sales, and the three-foot rule on championship sites due to tight gyms and how P.I.A.A. cannot certify courts for championships.

Curtis Whitesel notified the Committee on swimming and diving championships that included Penn State University lowering site costs (due to shortened day), two pool records being set (including college competitions), and a talented Bedford swimmer.

**New Business**

**Review of Disqualifications** - Chris Rickens updated the Committee on the five disqualifications that took place since February's meeting. All documents to date have been entered. Three of the disqualifications were supplemental and all of those were players. The remaining two were regular disqualifications, one player and one coach. To date there have been thirty-six disqualifications, thirty-one players, twenty of those being supplemental, five coaches, and two of those being supplemental disqualifications.

William Marshall updated the Committee on the 2023-2024 elections: vacant positions and new nominations.

On a motion by Timothy Regan and Ralph Cecere, the Committee unanimously approved William Marshall to the Superintendent Representative position for a one-year term.

William Marshall discussed the leadership transition one-year plan for the next chair that included online portals, the successor as a possible vice chair, and stipends.

William Marshall informed the Committee that the District VI Basketball Chair position will be open for the 2025-2026 school year, due to Michael Hudak and William Marshall resigning after the 2024-2025 season and that Cullen Stokes has shown interest in the position. William also stated that with all the zoom meetings, etc. that it would be advisable to have two people sharing this task.

The Committee discussed April meeting agenda items that included championships being bound by dates and the promotion of smaller sports such as rifle and bowling. Charles Gojmerac suggested a sanctioned bowling tournament.

The Committee was updated on the P.I.A.A. Right to Know requests supreme Court ruling by William Marshall.

On a motion by Curtis Whitesel and Molly Pomeroy-Hoover, the Committee unanimously approved the girls' soccer co-op between Curwensville and Moshannon Valley.

On a motion by Charles Gojmerac and Ralph Cecere, the Committee unanimously approved the junior high wrestling co-op between Bishop McCort Junior High and Bishop Carroll Junior High.

William Marshall discussed the email regarding Dean Rossi Scholarship recipients for 23-24 school year from Jeffrey Miller and the member schools that have not yet submitted their recipients.

Stacy Kuster inquired about the softball co-op between Bishop Guilfoyle and Bishop Carroll. William Marshall stated that the co-op was denied due to the classifications.
