**Call to Order:** Chairman Cecere called the September 8, 2025 meeting of the District VI Committee to order at 3:30pm at Hollidaysburg Area Senior High School.

**1.** Public Comment - There were no public comments.

## 2. Hearings

- 2.A. Juniata Valley Postseason Waiver Denial Appeal 4:00PM On a motion by Tina Greene and Jennifer McConnell, the Committee deemed a Juniata Valley Student Athlete postseason ineligible for football, based on Article 6, Section 7.c., number 2. The vote was 16 yes, 0 no.
- **3.** Approval of Minutes On a motion by Richard Schreier and Jennifer McConnell, the Committee unanimously approved the minutes of the August 4, 2025 meeting.
- **4.** Financial Report(s) Mrs. Mento
  - 4.A. District 6 Monthly Expenses/Revenue Report On a motion by Charles Glasser and Elizabeth Campbell, the Committee unanimously approved the District VI monthly financial report for August.
  - 4.B. Financial Accounts
    - 4.B.1. CD Renewed at 3% Ralph Cecere informed the Committee that the CD account has been renewed at three percent interest rate.
  - 4.C. <u>District VI Fee Structure</u> Ralph Cecere shared the revised District VI Fee Structure with the Committee.
    - 4.C.1. Girls Wrestling Tournament Stipends and Fees On a motion by Michael Cacciotti and Cullen Stokes, the Committee unanimously approved to create a wrestling tournament director position at a stipend of \$750.
  - 4.D. On a motion by Curtis Whitesel and Tish Maclay, the Committee unanimously approved to close the First Summit Bank account and to transfer the remaining funds from the First Summit Bank account to Arbiter Sports.

## **5.** Old Business - Committee

- 5.A. Recent Court Ruling Private Student Participation in Public Extracurriculars
- 5.B. Lawsuit filed Ralph Cecere notified the Committee of a lawsuit that was filed, where a Court of Common Pleas Judge ruled that evidence can be presented in appeals. Which in

resulted in the school district, who requested the transfer waiver be reviewed, attempting to drop their claims. The PIAA State office ruled that school districts cannot withdrawal their claims after the fact. On a vote of 5-0, the PIAA Board of Directors upheld District VI's ruling, where it will proceed to the Commonwealth.

- 5.C. PIAA Appeal Hearings Three (3) Bishop McCort held Tuesday, Aug 5, 20255.C.1. One Seeking Injunction Ralph Cecere informed the Committee of three PIAA appeal hearings where one is filing for an injunction.
- 6. New Business Committee
  - 6.A. ICC Championship Requests On a motion by Richard Schreier and Jody Rainey, the Committee unanimously approved the ICC Championship request, that includes junior high sports.
  - 6.B. Website Rankings Stipend Increase (Elling/Kline) On a motion by Phil Riccio and Tina Greene, the Committee unanimously approved the website rankings stipend increase from \$100 to \$200 per sport, with a total yearly increase of \$800.
  - 6.C. Mifflin County Attendance Medical Wavier On a motion by Tina Greene and Stacy Kuster, the Committee unanimously approved an attendance medical waiver for a Mifflin County Student Athlete.
- 7. Eligibility: Ralph Cecere stated that according to the By-Laws, post-season waiver requests must be submitted at least thirty days prior to competition. Mr. Cecere continued that the By-Laws also include a list of eligible waivers and school district does not need to submit waivers if the student meets the criteria. However, if a third school district calls for review and no waiver request was made and the student is found with motive, every sport event that student participated in is deemed a forfeit. On the other hand, if there was a transfer waiver and the District VI Committee already ruled on the student and then is later found with motive, there is no forfeits.
