Call to Order: Chairman Cecere called the October 6, 2025 meeting of the District VI Committee to order at 3:30pm at Hollidaysburg Area Senior High School.

1. Public Comment - There were no public comments.

2. Hearings

- 2.A. Chairman Cecere announced the 4PM supplemental disqualification hearing will be rescheduled. On a motion by Michael Cacciotti and Chris Rickens, the Committee unanimously approved to suspend Brian Boone, Girls Volleyball Assistant Coach, from District VI events until all supplemental disqualification requirements are met.
- **3.** Approval of Minutes On a motion by Charles Gojmerac and Charles Glasser, the Committee unanimously approved the minutes of the September 8, 2025 meeting.
- 4. Financial Report(s) Mrs. Mento
 - 4.A. District 6 Monthly Expenses/Revenue Report On a motion by Richard Schreier and Timothy Regan, the Committee unanimously approved the District VI monthly financial report for September.
 - 4.B. Financial Accounts Mrs. Mento told the Committee that once the \$21,470 check to Arbiter Sports is processed; they will be able to close the bank account.

5.A. Ralph Cecere briefed the Committee on the PIAA/Regional Panel Decision agreement to regarding eligibility.

- 6. New Business Committee
 - 6.A. Consent Order Private School Participation if No Sport Chairman Cecere shared the following with the Committee:
 - 6.A.1. Students enrolled in a Private Faith-Based School for sports not sponsored by their school, the following provisions apply:
 - 6.A.1.1. Schools are encouraged to enter into a Cooperative Sponsorship Agreement with another PIAA member school, as detailed under Article III, Section 10. A Cooperative Sponsorship Agreement will afford all students enrolled in the school the opportunity to participate as part of the Agreement; or

- 6.A.1.2. Absent a Cooperative Sponsorship Agreement, students enrolled in a Pennsylvania Private Faith-Based School that does not offer a particular interscholastic sport(s) are eligible to participate in that sport(s) at the school which they would otherwise attend, in the public school district of their residences, provided that the students meet all other eligibility requirements, including, but not limited to, school verified evidence of full-time attendance, enrollment and completion of the CIPPE.
- 6.A.1.3. Enrollment, Insurance, Transportation, Tryouts, Adding to Eligibility List
- 6.A.2. Cooperative agreements remain in effect for four years, after which one school may choose not to renew. If both schools mutually decide to terminate the agreement, they may do so at any time.
- 6.B. Ralph Cecere announced the following PA Broadcaster/PIAA Agreement (Not D6 Playoffs)
 - 6.B.1. Agreement 25% discount on audio only for PIAA play-offs
 - 6.B.2. Connect to NFHS Feed and broadcast PIAA play-offs for free.
 - 6.B.3. 75% of the home games of a team may broadcast PIAA Play-offs involving that team.
 - 6.B.4. Does not include District play-offs.
- 6.C. House Bill 102 Assaulting an Official Ralph Cecere updated the Committee about recent efforts to reach out to senators and representatives regarding House Bill 102.
- 6.D. Executive Committee Stipends On a motion by Cullen Stokes and Phil Riccio, the Committee unanimously approved an annual Executive Committee stipend of \$1000 to Michael Cacciotti and Curtis Whitesel, to be paid each December.

 - 12.A.2. Michael Cacciotti provided soccer information with the Committee, that included the first round will be held October 20-24 and the last date to enter is October 16th.
 - 12.A.3. Phil Riccio announced that the Girls Team Tennis may be pushed back one day due to weather.
