Call to Order: Chairman Cecere called the November 3, 2025 meeting of the District VI Committee to order at 3:30pm at Hollidaysburg Area Senior High School.

1. Public Comment – There were no public comments presented at this meeting.
2. Hearings – The Committee discussed the following hearings scheduled for the day:

3. Approval of Past Minutes - On a motion by Richard Schreier and Phil Riccio, the Committee unanimously approved the minutes of the October 6, 2025, meeting.
4. Financial Report(s) - Mrs. Mento
 - 4.A. District 6 Monthly Expenses/Revenue Report - On a motion by Brian Randall and Curtis Whitesel, the Committee unanimously approved the District VI monthly financial report for October.
 - 4.B. Financial Accounts – On a motion by Jennifer McConnell and Charles Gojmerac, the Committee unanimously approved the closure of the First Summit Bank checking account, effective November 3, 2025.
5. Old Business - Committee
 - 5.A. Ideas for Annual Meeting – The Committee discussed ideas for the annual meeting, including limiting the business meeting and dinner to one hour each. It was noted that the state, through PSBA, is exploring a training session, and committee members were encouraged to send any meeting topic suggestions to Mr. Cecere.
6. New Business - Committee
 - 6.A. Bellwood-Antis Adding Girls Wrestling (2025-2026): On a motion by Phil Riccio and Michael Cacciotti, the Committee unanimously approved adding Girls Wrestling at Bellwood-Antis starting in the 2025-2026 season.

- 6.B. District 6 Winter/Spring Tournament Structure: The Committee discussed the situation at Mount Union related to a closed tournament since COVID-19 and considered how to proceed. Discussion included how each sport manages tournaments:
- 6.B.1. Basketball – Closed tournament
 - 6.B.2. Wrestling (team) – Open to moving tournament
 - 6.B.3. Wrestling (individuals) – Next person qualifies
 - 6.B.4. Spring sports – 67% standard qualification for teams
 - 6.B.5. Soccer – Schools have a .500 rule, others may opt out
- 6.C. PIAA Appeals: The Committee discussed a recent appeal involving a postseason-ineligible student athlete.
- 6.D. RV Football – Postseason: The Committee discussed an appeal and, following a suggestion by Tina Greene, to send a letter to the school district requesting more information regarding the school's STEM program to provide clarity to the District VI Committee.
- 6.E. Bishop McCort Junior High Basketball – Eligibility: The Committee was informed of a state eligibility hearing scheduled for November 4, 2025.
